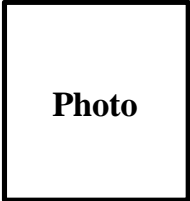

1. Students should be available in their respective rooms for attendance that will be taken in their respective blocks **everyday between 9:00pm - 10:15pm** in the biometric machines without fail.
2. Students should stay only in the room allotted to them. Staying in other student's rooms is not permitted. Unauthorized entry in non-AC room will carry the penalty of Rs. 2000/- and unauthorized entry in AC room will carry a penalty of Rs. 10,000/-.
3. Any physical/mental harassment towards fellow students including ragging, quarrelling, using abusive language and **violent behavior** is strictly prohibited. If found involved in any such activity, severe action will be taken as per university code of conduct.
4. **Smoking** is strictly prohibited inside the hostel premises and within the campus of the University and if found suitable action will be taken as per university code of conduct.
5. Hostel is meant for facilitating studies. Therefore, **silence** should be maintained between 9:30 pm to 6.00 am. Students should not disturb other students by conducting parties, playing music,

talking loudly over mobile phones, etc.

6. For any kind of misbehavior with hostel staff and authorities, strict action will be taken.
7. Any kind of medical history should be informed to the hostel authorities during the onboarding.
8. Multi-Level Marketing (MLM) and **gambling** in any form including playing cards in the hostel is prohibited.
9. Students found entering the Institution/Hostel premises under the influence of alcohol or inducing others to consume alcohol, will be **suspended for one semester**. If a student is found **consuming/possessing (even empty bottles)** liquor inside the campus/hostel premises he/she will be **suspended for one year**.
10. In case of any contraband substances are found in any room, all the students staying in the room will be **expelled** from the University. Students who consume/trade/possess narcotics inside/outside the hostel will be expelled from VIT Bhopal University.
11. Anyone causing **damage** the hostel **property** will be **penalized** as per the university policy.
12. Hostel students should **not bring any day-scholar** or **ex-VITian** or **non-VITian** inside the hostel premises.
13. If a student is going out for an overnight stay, He/She should **obtain prior permission** before leaving the hostel as per procedure.
14. Hostellers are not allowed to keep any kind of motor vehicles. However, **bicycle can be used**.
15. Students in the hostel are not allowed to keep **air coolers, musical instruments, speakers, electric kettle, induction stove, electric iron or any other electrical equipment/gadgets**. Unauthorized possession will lead to confiscation of the goods. Cooking in the rooms is strictly not permitted because of fire safety reasons.
16. Students are *personally responsible to safeguard their belongings*. Students are advised not to keep large amounts of cash or valuables like gold, costly wrist watch/cell phone, expensive jewellery etc., in their rooms.
17. All the programmes offered are residential programmes. Hence, students **will not be permitted to stay as day boarders outside the campus** until the completion of the course unless their parent stays with them.
18. First year students will be permitted for **shopping and outing** only after 2 months of joining (**on submission of Joint Affidavit by Parent/Guardian and the Student**).
19. Students will be permitted to go on leave to home town/Local guardian's place only twice in a month after parents' approval.
20. Students will not be permitted to stay in the hostel during **vacation**, unless they have academic

assignments.

21. Summer semester fees will be applicable to students registering for **summer courses**.

22. Outside food is strictly prohibited inside the hostel rooms.
